


During the previous period, AFSARD continued with the evaluation process for all received applications under the first published public call from the IPARD Programme 2014-2020. Currently, Agency for financial support in agriculture and rural development has 47 contracts signed for measure 1 and also 14 contracts for measure 3. Total amount of the financial support for measure 1 is 950.065,00 euros (EU contribution 712.549 euros). For measure 3, total amount of the financial support of the contracted projects is 4.047.512.00 euros (EU contribution 3.035.634,00 euros).

In the evaluation process, Agency has also issued 342 decisions for rejection of the application for measure 1, 18 decisions for rejection of applications submitted under measure 3 and 102 decision for rejection of applications submitted under measure 7.

Main reason for rejection of applications in measure 1, measure 3 and measure 7 is that the applicants did not respond to the notification for completing the application. Additionally, in measure 3 several applicants were not eligible for financial support because they are not in the range of small and medium enterprises.

Main problems regarding the administrative process remain large number of received applications and insufficient number of employees, time needed to obtain the reference price for the investments, number of controls for each application etc.

Organization of the IPARD Monite



Regarding the planned payments from the IPARD II Program, we inform you that it depends on the dynamics of concluding agreements and realization of the investments from the recipients, i.e. according to previous experience it is expected that in 2018, the Agency would pay a total of around 3.25 million Euros for co-financing, and the rest during 2019 and 2020 in line with the deadlines for the realization of the investments.

So far, 10 payment requests have been received, for the measure Investments in tangible assets for agricultural holdings Total amount requested is 1,672,623.52 denars.

For the measure Technical assistance 2 claims for payment has been received from Ministry of agriculture, forestry and water economy – Managing authority, claimed amount 113.428,00 MKD for the claim for payment for the Monitoring committee (Committee for following IPARD II program) and claimed amount 48.900,00 MKD for the claim for payment for Office materials.

Total claimed amount 162.328,00 MKD.
