### III. RESULTS OF THE IPARD II MONITORING COMMITTEE MEETING

### Opening of the meeting

Mr. Liam Breslin, representative of the European Commission, welcomed members of the Monitoring Committee. He noted that 2019 was a challenging year for North Macedonia, as it had to pay EUR 8.7 million by end of the year. Mr. Breslin emphasized that the country would achieve this target if all submitted payment claims would be authorized and paid until 31 December 2019. If done, this would be a historic year as North Macedonia never has paid so high amount under IPARD and avoided de-commitment. It is also historic year as the IPARD Agency paid the largest IPARD amount per project - Podgorka.

Mr. Breslin thanked the Minister and all the responsible authorities – particularly, staff in the IPARD Agency – for achieving this result despite all the challenges and difficulties.

He invited the Government and, particularly, Ministry of Agriculture, Forestry and Water Economy together with Ministry of Finance to address the issue of the staff vacancies as soon as possible by filling in the human resource gap and providing constant improvement of their professional knowledge and qualities along with relevant working environment. This has been one of major problems that has significantly affected successful implementation of IPARD Programme so far.

Mr. Breslin emphasized that North Macedonia would now be considered as a country introducing new progressive solutions like elimination of incomplete applications and plans to introduce eapplications, which would make it exemplary in Western Balkans.

At the end of his opening speech, he reminded the MC members that 2020 would be the last year of the current programming period, which would require significant efforts by the national authorities to prepare for IPARD III. In this regards, DG AGRI is happy to see that relevant activities are already foreseen in the Technical Assistance Action plan for 2020. Mr. Breslin assured that the IPARD Unit would provide further assistance in this respect.

1. With reference to point 1 of the agenda: "Adoption of the draft agenda for the sixth (autumn) meeting of the IPARD Monitoring Committee 2014-2020".

The Chairperson of the IPARD Monitoring Committee (IPARD II MC), Mr. Nefrus Celiku opened the sixth meeting of the Committee by welcoming all attendees. He informed the members on the proposed agenda for the sixth meeting of the IPARD MC.

None of the members of the Committee had any remarks regarding the agenda, and the following decision was adopted:

Decision No. 1: IPARD Monitoring Committee 2014-2020 adopted the agenda for the sixth meeting of the Monitoring Committee.

2. With reference to point 2 of the agenda: "Adoption of the minutes from the previous fifth (spring) meeting of the IPARD Monitoring Committee 2014-2020 held on May 21, 2019"

The Chairperson of the IPARD Monitoring Committee 2014-2020 informed that the minutes from the previous meeting of the Monitoring Committee of IPARD 2014-2020 held on 21st of May 2019, were sent to the members of the IPARD Monitoring Committee on 24th of June 2019, and no comments were submitted to the Secretariat of the IPARD Monitoring Committee 2014-2020 till July 8, 2019 from the members of the Monitoring Committee of IPARD 2014-2020.

The members of the IPARD MC did not have any remarks on the minutes and the following decision was adopted:

Decision No. 2: The IPARD Monitoring Committee 2014-2020 adopted the minutes of the fifth meeting of the IPARD Monitoring Committee 2014-2020, held on  $21^{\rm st}$  of May 2019, as final.

3. With reference to point 3 of the agenda: "Information on the implementation of the decisions /conclusions adopted at the previous fifth (spring) meeting of the IPARD Monitoring Committee 2014-2020"

The Head of the Managing Authority, Mr. Zhivko Brajkovski, informed on the progress made in the implementation of the decisions/conclusions adopted at the previous meeting of the IPARD Monitoring Committee 2014-2020 as well as on the decisions adopted by written procedure, i.e.:

- Second amendment of the IPARD Programme 2014-2020, in the part of the financial plan and financial tables with reallocations of funds for 2019 and 2020;
- Annual Report on the Implementation of the IPARD Programme 2014-2020 for 2018;
- Proposal for first modification of the Action Plan of planned activities with the measure "Technical Assistance" (APTA) for 2019.

Regarding this item, the members of the Committee adopted the following conclusion:

Conclusion No. 1: The IPARD Monitoring Committee 2014-2020 was informed on the progress made in implementing the decisions/conclusions of the fourth meeting of the IPARD Monitoring Committee 2014-2020.

4. With reference to point 4 of the agenda: "Information on appointments of new members of IPARD II MC"

Regarding this item, the Chairperson of the IPARD Monitoring Committee 2014-2020, Mr.Nefrus Celiku informed about the new members of the IPARD Monitoring Committee 2014-2020. New members of the IPARD Monitoring Committee are:

The following conclusion was adopted:

Conclusion No.2: The IPARD Monitoring Committee 2014-2020 was informed on appointments of new members of IPARD II MC.

5. With reference to point 4 of the agenda: "Information regarding the IPA Monitoring Committee held on  $30^{th}$  of October 2019"

Considering that NIPAC representatives were not present at the meeting, point 5 was not presented and there was no discussion or conclusion.

6. In relation to point 6 of the Agenda: "Status with the implementation of the IPARD Programme 2014-2020"

6.1. Sub-item 5.1 of the agenda: "General information about programme/measure implementation on the basis of monitoring indicators, tables"

Regarding this sub-item, the MA representative, Mr.Viktor Mladenovski presented the Annual monitoring report for the implementation of the IPARD Programme 2014-2020, informing that the main indicators for implementation are with status as of 31<sup>st</sup> of October 2019, while the indicators that provide information regarding the type of production or type of investment are with status as of 30<sup>th</sup> of June 2019. Attendees at the meeting were informed about the implementation of the three measures of the IPARD Programme 2014-2020, public calls and etc. The representative of the EC, Mr. Zigo Rutkovskis noted that this was a successful year for the IPARD Programme 2014-2020 and asked for an assessment of the made progress, i.e. identifying in which areas additional support is needed, in order to avoid a situation where some sectors would become more advanced than others.

Regarding the question by the representative of the EC, Mr.Liam Breslin why farmers cannot obtain building/reconstruction permits, the Head of MA Mr. Zivko Brajkovski responded that the basic problem is that rural areas do not have detailed urban plans based on which construction permits are issued. He also pointed out that the Law on Agricultural Land provides a procedure by which MAFWE can issue an approval for any type of construction that is in function of agriculture, as well as for rural tourism. IPARD MA has prepared a guideline explaining how to obtain this license and it will be published on the IPARD website.

Regarding getting a building permit, the representative from Association of Farmers, Mr.Eftim Shaklev, noted that the problem exists since the beginning of the IPARD Programme. Obtaining a building permit for agricultural land and a building permit for construction land were identified as major problems for farmers. For construction land there are other requirements for obtaining a permit, and almost no municipality has developed a detailed urban plan for suburban areas and villages. All this prevents farmers from applying for IPARD because they do not have the basic document: a building permit.

Regarding the question by Macedonian Ecological Society (MES) representative, Ms. Frosina Pandurska Dramikanin, whether subsidies for landscape management (subsidies for local people to breed livestock for pasture on a certain landscape) can be provided under Agro-ecological, EC representative Mr. Liam Breslin responded that IPARD Operating Structure can think in that direction and ask for the issue of permits to be resolved as soon as possible.

Regarding this sub-item, the following conclusion was adopted:

Conclusion No.3: The IPARD Monitoring Committee 2014-2020 was informed on general information about programme / measure implementation on the basis of monitoring indicators, tables.

### 6.2. Sub-item 6.2 of the agenda: "Information on the progress of activities of IPARD Agency"

The AFSARD representative, Mr. Vangel Nanevski noted that the IPARD Agency has been working intensively in order to avoid de-commitment for 2014, 2015 and 2016 worth € 8,7 million (EU contribution). He presented the data from the Public Call 01/2017 of the IPARD Programme 2014-2020. Concerning Measure 1, 893 contracts were concluded with total EU contribution of 8,3 million €. For Measure 3, 31 contracts have been concluded with a total EU contribution of 4,8 million € and 23 contracts were concluded for Measure 7 with a total EU contribution of 3,22 million €, i.e. total financial amount of 16.000.000 € (EU contribution) only from Public Call 01/2017.

The AFSARD representative, Mr. Vladimir Hristov presented the data regarding the payment. Regarding Public Call 01/2018, 8 payment requests have been processed with total amount of 550.000 € or € 410.000 (EU contribution). Regarding Public Call 01/2017 as of 10.12.2019, 819 applications were approved (regarding the three measures including the Technical Assistance Measure) in total amount of 9,9 million € (EU contribution). 8,3 million € was paid, but the payment will continue and these funds will be paid to all applicants that have received a decision for payment. Regarding Measure 1, 847 payment requests with a total amount of 8,2 million € have been received, 779 requests with 5,7 million EU contribution have been approved for payment. As for Measure 3, 30 payment requests were submitted with a total amount of 6,1 million €. 27 requests were approved with a total amount of 4,1 million € (EU contribution). There are still 3 payment requests that are being processed. Regarding Measure 7, 9 payment requests were submitted, out of which 6 are already approved, totaling 52.000. The value is lower than other measures as it is an investment in beekeeping. Contracts worth 3,2 million euros (EU share) have been concluded.

The representative from AFSARD, Mr. Vangel Nanevski presented the results of other public calls. Regarding the first Public Call for Measure 3, 37 contracts have been concluded (3 more are expected to be concluded by the end of 2019). The current financial support is in total amount of 4,8 million €, and the remaining 3, around 3 million €. Regarding the second Public Call in 2018, 1.099 applications were received, 403 were rejected, and 371 contracts were concluded with total amount of 2.500.000 € (EU contribution). The first public call for Measure 7 in 2019 lasted 60 days. 261 applications were received with a total requested financial support of 43,8 million €. 18 applications have been rejected due to incomplete applications. He also announced a public call for Measure 3 by

the end of 2019, and Measure 1, in the second half of January 2020. Attendees at the meeting were informed about the modification of the IPARD Programme 2014-2020, which provides processing only complete applications.

Responding to question raised by Mr. Z.Rutkovskis on quality of project applications since the decision on refusal of empty/incomplete applications, Mr. V.Nanevski informed that the overall quality of the applications has improved. This would reduce time required for assessment and signing project contracts.

Mr. Z.Rutkovskis raised attention of the MC members to the issue of staff capacity at the IPARD Agency, which prevents from even better results in IPARD implementation and might lead to burnout of current employees. He invited the MC members as IPARD stakeholders jointly to raise attention of the responsible Government authorities to the issue.

Regarding this sub-item, the following conclusion was adopted:

Conclusion No.4: The IPARD Monitoring Committee 2014-2020 was informed on the progress of activities of IPARD Agency.

6.3. Sub-item 6.3 of the agenda: "Information on functioning of the monitoring and control system"

"Information on the status with the entrustment of budget implementation tasks for measure Rural Public Infrastructure"

"Information on financial implementation of IPARD and use of interest earned"

The NAO representative, Ms. Aleksandra Simjanoska, informed the Committee regarding the management and control system of IPARD.

She proposed that projections for announcement of Public Calls or payments should be submitted to NAO, as part of the Operation Structure, after appropriate processing and consultation of all concerned parties involved. She also asked for accuracy of projections.

In order to facilitate the accurate determination of the required number of employees, which affects the speed and quality of the processing of applications and the approval of payment requests at a later stage, it was suggested that AFSARD and NAO refer only on sectors directly related to application processing and payment requirements in their Workload Analysis.

The IPARD Monitoring Committee 2014-2020 was also informed regarding the verification visits by NAO, the internal audits carried out during 2019 by the Internal Audit Department within each institution.

Regarding this sub-item, members of the MC adopted the following conclusion:

Conclusion No.5: The IPARD Monitoring Committee 2014-2020 was informed on functioning of the monitoring and control system.

7. With reference to point 7 of the agenda: "Discussions on modification of the IPARD Programme 2014-2020"

7.1 Sub-item 7.1 of the agenda: "Information on approved second modification of the IPARD Programme 2014-2020"

The MA representative, Mr. Aleksandar Anteski informed about the second modification of the IPARD Programme 2014-2020. The reason for the second modification of the IPARD Programme 2014-2020 is the prolonged accreditation of the measure "Rural Public Infrastructure", as well as the increased risk of de-commitment. Therefore, funds from this measure were allocated to Measure 7 and Measure 3.

Regarding this sub-item, members of the MC adopted the following conclusion:

Conclusion No.6: The IPARD Monitoring Committee 2014-2020 was informed on the second modification of the IPARD Programme 2014-2020.

7.2 Sub-item 7.2 of the agenda: "Discussion on the third modification of the IPARD II Programme 2014-2020 and List of eligible expenditures"

The MA representative, Mr. Aleksandar Anteski informed that in order for successful implementation of the IPARD Programme 2014-2020, a third modification of the Programme is planned in the upcoming period. It foresees increasing total eligible expenditure for proposed projects from 3.000 € to 10.000 € in denar equivalent and introduction of new measures in the IPARD Programme 2014-2020:

- "Agri-environment-climate and organic farming" measure;
- "Advisory services" measure;
- "Implementation of local development strategies LEADER Approach" measure.

The EC representative, Mr.Zigo Rutkovski pointed out that the proposal for third modification proposal is acceptable in principle. He raised attention of the MC members to importance of having common understanding among all national authorities and the MC members that the introduced measures do not guarantee their implementation under IPARD II – due to lack of the staff in the IPARD Agency,- but would rather serve as a preparation for IPARD III.

Mr. Z.Rutkovskis invited the MA to consult the Audit Authority in order to overcome certain discrepancies and delimitations between Measure 1, Measure 3 and Measure 7 related to the criteria that define the eligibility of investments under Annex 1 of the EU Treaty, in order to improve comprehensibility of the program document.

Regarding this sub-item, the IPARD Monitoring Committee 2014-2020 adopted the following conclusion:

Conclusion No.7: The IPARD Monitoring Committee 2014-2020 was informed on the third modification of the IPARD II Programme 2014-2020 and List of eligible expenditures.

7.3 Sub-item 7.2 of the agenda: "Preparatory activities for Agro Environmental measure"

The MA representative, Mr. Aleksandar Anteski informed about the preparatory activities for Agro Environmental measure. Regarding activities that already have been undertaken, he noted that with the support of an EU funded project (EuropeAid/129386/C/SER/MK) "Development and Implementation of Agri-environment Measures" in 2010, documents/procedures have been drafted:

- · Agri-environment programme;
- · Working procedures in AFSARD;
- Memorandum of understanding (MoU);
- Proposals for amending Low on Agriculture and RD;
- System for sanctions (and all the necessary documentation needed for accreditation of the measure).

Considering that these documents were prepared many years ago, it is necessary to update them in accordance with the needs of harmonization with the legislation and the defined national strategic needs.

Regarding planned/future activities, he pointed out that a study visit to the Republic of Turkey is planned, in order to gain the necessary experience in programming, control, implementation and financial management of agri-environmental measures. Consequently, the operating structure for IPARD (MA, AFSARD and NAO/NF) would start with preparation and updating all the necessary accreditation documents in order to introduce the measure in IPARD Programme and its successful implementation.

Regarding this sub-item, the following conclusion was adopted:

Conclusion No.8: The IPARD Monitoring Committee 2014-2020 was informed on preparatory activities for Agro Environmental measure.

# 8. With reference to point 8 of the agenda: "Technical Assistance activities" Sub-item 8.1 of the agenda: "Information on the progress of APTA 2019 implementation"

The MA representative, Mr. Kiril Ristoski informed about the undertaken and future activities of APTA for 2019. Bearing in mind the lengthy process of adoption of the new APTA template and its first modification, the whole process of implementing APTA 2019 has been slowed down, as the EC has further requested an intervention in the new APTA template, with the aim of inserting a column to explain the type of procurement under the EU PRAG rules. The change was implemented in cooperation with NAO, along with other modifications to the Programme that were implemented during October 2019.

For this reason, a need for a second modification of APTA 2019 is being imposed at this time, due to the transfer of part of the unrealized procurements to APTA 2020.

Regarding this sub-item, the following conclusion was adopted:

Conclusion No.9: IPARD Monitoring Committee 2014-2020 was informed on the progress of APTA 2019 implementation.

### 8.2 Sub-item 8.1 of the agenda: "Adoption of APTA 2019 (modification 2)"

The MA representative, Mr. Kiril Ristoski presented the changes of APTA 2019. After approving the simplified layout of APTA, the Managing Authority, submitted a request for APTA 2019 first modification. The modification was imposed as a need to reflect changes in the APTA form and to insert procurement for:

- appropriate system for checking the connection of companies outside the country, which are requesting IPARD funds;
- office supplies needed for the Managing Authority;
- translation of IPARD Programme 2014-2020 and all its modifications;
- services for IPARD Website Maintenance and extension of ipard.gov.mk domain.

Regarding this sub-item, the following conclusion was adopted:

#### Decision No.3: IPARD Monitoring Committee 2014-2020 adopted the APTA 2019 (version 2).

#### 8.3 Sub-item 8.3 of the agenda: "Adoption of APTA 2020"

The MA representative, Mr. Kiril Ristoski presented the activities foreseen in the APTA for 2020 i.e.:

- Procurement for organizing the next 6 meetings of the "Monitoring Committee of the IPARD Programme 2014-2020";
- Procurement for the "IPARD Programme 2014-2020 Publicity Campaign";
- Procurement related to visits and seminars;
- Procurement of office supplies for the needs of the IPARD Managing Authority;
- Procurement for the IPARD Programme Evaluation 2014-2020 and Procurement for Organization of Evaluation Steering Groups;
- Procurement for the Enhance the capacity of the administration engaged in the management, implementation, control, monitoring of TA measure;
- Procurement for Improvement and Upgrading of IPARD Programme 2014-2020 monitoring system;
- Procurement for a Workshop to Improve the Implementation of the Measure of Technical Assistance;

EC representatives expressed their approval with the undertaken publicity activities, noting that this is another area with outstanding results.

In response to the question by EC representative Mr. Liam Breslin whether successful IPARD projects are published on IPARD website, MA representatives Mr. Alexandar Anteski and Mr. Zivko Brajkovski answered that successful IPARD projects were presented during the info days. They will also be published on the IPARD website.

9. With reference to point 9 of the agenda: "Information/discussion on results of the on-going evaluation of IPARD Programme"

9.1 Sub-item 9.1 of the agenda: "Information on ex post evaluation of the IPARD Programme 2007-2013"

The MA representative, Mr. Aleksandar Anteski presented the undertaken activities regarding ex post evaluation of the IPARD Programme 2007-2013. The purpose of the ex-post evaluation of the IPARD Programme 2007-2013 is to evaluate:

- Level of resource utilization;
- Efficiency and effectiveness;
- Socio economic impact and
- Impact on defined priorities.

Mr. Anteski informed that the activities for ex-post evaluation of IPARD 2007-2013 are ongoing and in final stage. Independent evaluator contracted using Measure 9 assistance, to prepare and submit to MA first draft of the Final Ex-Post Evaluation Report. Even though activities under the contract and evaluation of IPARD Programme 2007-2013 are well advanced and underway, the MA shall request extension to the EC services (DG AGRI) in order to receive high quality report which will particularly assist within the next programming period by the end of April 2020.

Regarding this sub-item, the following conclusion was adopted:

Conclusion No.11: IPARD Monitoring Committee 2014-2020 was informed on ex post evaluation of the IPARD Programme 2007-2013.

# 9.2 Sub-item 9.1 of the agenda: "Information on ongoing evaluation of IPARD Programme 2014-2020"

The representative from MA, Mr.Aleksandar Anteski, informed about the on-going evaluation of the IPARD Programme 2014-2020. The following were identified as obstacles to the implementation of the evaluation activities:

- Lack of human capacities in terms of evaluation activities;
- Delayed data submission by the IPARD Agency;
- Manual data processing in the IPARD Agency;
- Incompatible data regarding the implementation of the IPARD Programme 2014-2020.

The Head of MA, Mr.Zivko Brajkovski expressed his gratitude to the Delegation of the European Union in Republic of North Macedonia and the cooperation with IPARD Agency for the development of the future software, where MA is planned to have access to read-only data regarding the

implementation of the measures of the Programme and use the data for monitoring and evaluation purposes. He also noted that a significant part of the identified weaknesses in the monitoring and evaluation system will be overcomed with the help of this software.

Regarding this sub-item, the following conclusion was adopted:

Conclusion No.12: IPARD Monitoring Committee 2014-2020 was informed about the ongoing evaluation of IPARD Programme 2014-2020.

### 10. With reference to point 11 of the Agenda: "AOB"

The EC representative, Mr. Liam Breslin, proposed for the next IPARD Monitoring Committee, to add an item to the agenda regarding the IPARD Programme 2021-2027. The proposal was accepted by the Head of MA, Mr.Zivko Brajkovski, noting that it is the goal of the IPARD MC, to provide positive guidance to MA, IPARD Agency and all IPARD structures in order to improve the successful implementation of the IPARD Programme.

## 11. With reference to point 11 of the Agenda: "Proposal for the Agenda of the next seventh IPARD 2014-2020 MC meeting/agreement on indicative new date"

Regarding point 11 of the Agenda, the Chairperson informed on the draft agenda for the seventh meeting of the IPARD Monitoring Committee 2014-2020.
