## II. RESULTS OF THE IPARD PROGRAMME 2021-2027 MONITORING COMMITTEE MEETING

### Opening of the meeting

The Chairperson of the Committee, Mr. Redzail Ismaili, opened the first meeting of the Committee by welcoming all attendees.

Mr. Frank Bollen, Head of Unit G4 at DG AGRI, welcomed the members of the IPARD III MC to the first meeting in North Macedonia and overall - in the IPARD countries. He recognised efforts by the national authorities to make IPARD more efficient and broader by introducing new measures. In order to use provided opportunities, Mr. Bollen encouraged to strengthen capacity in all responsible IPARD authorities along with increasing knowledge and skills of stakeholders, which would increase information about IPARD instrument and quality of submitted project applications. He wished the participants to maintain the achievements under IPARD II and ensure further improvements as that would play a significant role during accession of North Macedonia to the European Union.

**With reference to item 1 of the Agenda: "Adoption of the draft agenda for the first meeting of the IPARD Programme 2021-2027 Monitoring Committee":**

None of the members of the Committee had any remarks regarding the agenda, and the following decision was adopted:

With reference to item 3 of the Agenda: "Information on adoption of Draft Rules of Procedures of the IPARD Programme 2021-2027 Monitoring Committee of the Republic of North Macedonia".

The Head of IPARD Managing Authority, Mr. Zhivko Brajkovski informed about the adoption of Rules of Procedure of the IPARD Programme 2021-2027 Monitoring Committee. It was prepared in cooperation with all operational structures within the IPARD Programme as well as with the representatives of the EC. Rules of procedures were adopted by written procedure on 14<sup>th</sup> of March 2023.

Regarding this item, the members of the Committee adopted the following conclusion:

**Conclusion No. 2: The IPARD Programme 2021-2027 Monitoring Committee was informed regarding the adoption of Draft Rules of Procedures of the IPARD Programme 2021-2027 Monitoring Committee of the Republic of North Macedonia.**

With reference to item 4 of the Agenda: "Information on the adoption of the Sectoral Agreement and Financial Agreement for IPARD III":

Ms. Dana Petresca, the representative of the National IPA Coordinator, informed that after receiving the opinion from the Ministry of Foreign Affairs that it is not necessary to initiate a procedure for the ratification of the Sectoral Agreement for IPARD 2021-2027, it was signed and submitted to the Ministry of Foreign Affairs, the EU Delegation and all relevant institutions. After being signed by the Director General and the Deputy Prime Minister for European Affairs, the Sectoral Agreement entered into force on 15<sup>th</sup> of February 2023. The same procedure shall be applied for signing of the Financial Agreement.

Regarding this item, the members of the Committee adopted the following conclusion:

**Conclusion No. 3: The IPARD Programme 2021-2027 Monitoring Committee was informed regarding adoption of the Sectoral Agreement and Financial Agreement for IPARD III.**

With reference to item 5 of the Agenda: "IPARD Programme 2021-2027":

Sub item 5.1 of the Agenda: "Adoption of the first modification of the IPARD Programme 2021-2027":

IPARD MA representative, Mr. Aleksandar Anteski presented the details regarding the first modification of the IPARD Programme 2021- 2027. The IPARD Managing Authority has proposed these modifications as a result of the need for amendments in the IPARD III Programme in terms of referencing to the provisions of signed Financial Framework Partnership Agreement - FFPA and the Sectoral Agreement. These amendments will allow all supplies purchased under this Programme funds to originate from any country, which will lead to better and easier absorption of IPARD funds.

Regarding this sub-item, the following conclusion was adopted:

**Decision No.2: IPARD Programme 2021-2027 Monitoring Committee reviewed and adopted the first modification of the IPARD Programme 2021- 2027**

**Sub- item 5.2 of the Agenda: "Information on status of accreditation of IPARD III measures":**

Ms. Elizabeta Manusheva Apostolovski, the representative of the NAO, informed that the procedure for granting the right for indirect management of the IPARD III Programme is in the final stage, i.e., it is necessary to adopt the two decrees: establishment of mutual relations of the IPA structures, which is in the Government procedure and the Decree for IPARD, which is final stage, i.e. alignment with the Secretariat for Legislation. It is expected that the two decrees shall be adopted in the shortest possible time by the Government of North Macedonia. In order to submit the package to the EC, an official nomination of the Head of IPARD Managing Authority is also required. After the adoption of the two decrees, the National Coordinator for Authorization will submit the entire request to the EC for granting the right for indirect management within 10 days. In meantime, the process for signing the implementation agreements, memorandums of cooperation with the technical bodies and the agreements between the IPARD structures will be started.

Regarding this sub-item, the following conclusion was adopted

**Conclusion No. 4: IPARD Programme 2021-2027 Monitoring Committee was informed regarding the status of accreditation of IPARD III measures.**

**In relation to sub-item 5.3 of the agenda: "Information on the plan for public call under IPARD Programme 2021-2027":**

Mr. Vangel Nanevski, the representative of the IPARD Agency, informed that after the adoption of the two decrees and the signing of the Financial Agreement between EC and the Government of North Macedonia, the implementation of the IPARD Programme 2021-2027 will begin. Indicatively, the first public call is expected to be published in the second half of May or the beginning of June.

Regarding this sub-item, the following conclusion was adopted:

**Conclusion No. 5: The IPARD Programme 2021-2027 Monitoring Committee was informed on the plan for public call under IPARD 2021-2027.**


